# **Group Consultation Agreement toward EMDRIA Certification**

# **Objective**

The main objective of this case consultation group is to meet the consultation requirements for EMDRIA Certification. The focus will be on the clinical applications of EMDR therapy to one's professional practice, specifically on mastery of **standard EMDR therapy protocol for the treatment of PTSD.** Participants in this group are limited to clinicians who have already received EMDR therapy training by an EMDRIA accredited program. Some of the material covered in these seminars includes:

- Review of EMDR therapy treatment protocols
- Discussion of clinical cases
- Handling of common technical difficulties
- Presentations on topics of special interest

- Updates on clinical & research development
- Opportunities for videotape review
- Incorporating EMDR therapy into one's clinical practice

In order to amplify and expand on theoretical issues, case material will be discussed during these sessions. Consultee is encouraged to bring in his/her own cases for discussion that you are considering for EMDR therapy, or are already using EMDR therapy. Cases that are not related to the clinical use of EMDR therapy will not be discussed in this format.

#### **Limitation of Services**

It is expressly understood that no supervision or employment relationship exists between AP and Consultee. Consultee affirms that s/he is independently licensed to practice psychotherapy and maintains any and all insurances (including malpractice) and requirements necessary for practicing in his/her jurisdiction. It is understood that neither Ms. Stout, as AP, nor other therapists/participants shall be construed as providing supervision to another Consultee/participant on any specific case. While clinical possibilities will be discussed and ideas shared in relation to the clinical situations presented, the Consultee is solely responsible for the nature and quality of services provided to the client/patient.

### **Confidentiality**

Consultee will notify clients and obtain signed Release of Information for consultation prior to presenting any case material. Consultee will omit any potentially identifying information from all written or electronic materials and in oral discussions. Consultation will focus on general principles and fidelity in application of treatment for kinds of cases, not for specific or identified cases. Consultee understands that whatever information is presented in these sessions is to be kept confidential among the participants both during and after Consultee's participation in the group.

## **EMDRIA Certification Requirements**

After the 5<sup>th</sup> group session, Ms Stout will provide written documentation of consultation hours for the time Consultee has spent in these sessions. Consultee will receive a portion of these hours as individual consultation hours, if applicable, when Consultee presents and participates in discussion of case material from Consultee's clinical use of EMDR therapy.

#### **Fees**

Consultee will pay AP in advance a fee of \$400 for five 90 minute consultation sessions. Consultee will provide 24 hours notice to cancel. There are **no refunds** provided for any missed sessions. Consultee may attend another consultation group session, if available, as a make-up for a missed session.
